## The Plight of the Health Consumer

I am sure that most health librarians will agree that there is nothing more painful than talking to the mother who's son has just been diagnosed with a rare disease. She's looking for basic, easy to understand information on the disease and it's treatment. As most of you know, she's in a difficult situation, the majority of our libraries are not mandated to cover consumer health and thus she may end up with information that is too clinical for her needs.

We work during a time when more and more people are looking for answers to their own health problems. Doctors have less time to spend with patients and they have less time to research their patients health problems. This means that health library personnel will be dealing more often with patrons seeking consumer health care information. This situation becomes increasingly tragic when you realize that there is very little, basic, up-to-date information available for these patrons.

What we need in Manitoba is a collection devoted entirely for consumer health information. In this consumer health collection there would be easy-to-understand, up-to-date information on various different diseases and syndromes, basic information for those high school students doing projects, information on the self-help groups and associations available in Manitoba for those people with health

problems, and a sympathetic ear. This would be the ideal solution to our problems.

The reality is, that with budgetary difficulties and limited staff time, this collection may not come to pass any time soon. This leaves the health care consumer out in the cold. What we need is a solution.

What I would like to see is a running column of resources that the MHLA libraries have for consumer information. Perhaps amoungst ourselves we can share resources and make life a little easier for health consumers who are looking for help.

## From the President

At our fall meeting we passed a resolution to proceed with implementing DOCLINE in Manitoba. The ground work is being established for what hopes to be a successful implementation. A DOCLINE implementation committee has been created and a target date for implementation is set for May 1996. The first step is to have the MHLA Serials Union List updates from contributing libraries submitted by January 1996. The updates will then be loaded in NLM's SERHOLD. We realize that funding may be an issue for many member libraries to follow through with our implementation plans. A second resolution was passed at the fall meeting to address this concern. MHLA will subsidize the initial DOCLINE registration fee and the cost of uploading the MHLA Serials Union List into SERHOLD. We are also aware that not all libraries may have the necessary hardware to proceed with implementation and may need time to acquire the necessary equipment. As a result, implementation will be divided into two phases. Phase I will focus on the libraries that will be ready to proceed with DOCLINE by the target date. Phase II will implement DOCLINE in other libraries as they become ready to do so. The committee is currently planning workshops to assist libraries in implementing DOCLINE. Information on this will be sent out soon.

The current trend in government budget cuts to our health care system has alerted MHLA to the potential compromise in the quality of health care information services. In response to this, a committee has been organized to write a position paper on this issue and to send it to the Minister of Health of the Province of Manitoba and to other relevant parties. I hope that this will be the beginning of a dialogue with our organization and the people responsible for planning the future path of health care in our province.

Our winter meeting is scheduled on Wednesday, February 21, 1996, at the Deer Lodge Centre. An excellent program is planned in conjunction with the meeting. We arepleased to have Login Brothers present the latest healthcare CD-ROM and software products at a multi-media fair. I encourage all to attend and see what the future in information technology has in store for our profession.

In order to start things off I'd like to indicate a couple of interesting health resources available at the University of Manitoba Medical Library and over the internet.

The first one is a software product called Medical House Call. This product was reviewed by Bill Poluha a while back but the information is worth repeating. This product gives simple, easy to access information on a wide variety of illnesses. Each illness is cross referenced with drug and treatment information that the patient can understand.

A CD-ROM product that the Medical Library has that is more clinical in nature but still useful to the consumer is STAT-Ref. This CD-ROM product contains the full text of 27 standard medical textbooks including the USP DI drug handbooks and the Current Treatment and Diagnosis series. STAT-Ref has a simple search interface that shows search relevancy information.

SPACELINE covers clinical medical support to humans in space; physiology, metabolism, and growth and development of the cells, organs, and systems of humans, animals, and plants as they are affected by the space environment; environmental protection and life support for humans in space; psychological, behavioural, and human factors involved in living in the space environment; and, applications of space life sciences research to the improvement of life on Earth. SPACELINE consists of references to journal articles, technical reports, books, bookk chapters, conference proceedings, meeting abstracts, bibliographies, and audiovisual materials. Sources consist of all references is scope from several NLM databases, including MEDLINE journal article references from 1966 on, and thousands of citations from 1961 to the present contributed by NASA.

The Library of Congress is putting the finishing touches on Classification Plus, a new automated cataloguing tool. It is a full-text, Windows-based CD-ROM product combining Library of Congress Subject Headings, and Library of Congress Classification. Both will be published on a single CD-ROM disc. Driving Classification Plus is the same Folio software used in the companion product Cataloger's Desktop. Users can follow hypertext links between files, view headings in an expandable hierarchical display, and construct complex query searches using boolean, keyword, phrase, wild card, truncated, and proximity

searching. Classification Plus will be available as an annuala subscription with quarterly issues, for single-user workstation or on a local area network. More info can be obtained from the Library of Congress.

# **Book Review**

Current practice in health sciences librarianship. Alison Bunting, editor-in-chief. Metuchen, NJ: Medical Library Association and Scarecrow Press, 1994- Vol. 1, Reference and Information Services in Health Sciences Libraries. Edited by M. Sandra Wood. 1994. Vol. 2, Educational Services in Health Sciences Libraries. Edited by Francesca Allegri. 1995.

The first two of the eight projected volumes of this series have now appeared, and they are a welcome replacement for MLA's largely outdated threevolume Handbook of Medical Library Practice. Like the earlier publication, this new handbook aims to serve as a outdated three-volume Handbook of Medical Library Practice. Like the earlier publication, this new handbook aims to serve as a general introduction to the field of health sciences librarianship for both students and library staff and as a basic reference work for health sciences librarians and other information specialists. Volumes 1 and 2 are devoted to reference and educational services. Future volumes will cover information access and delivery, collection development, acquisitions, bibliographic management, the health sciences environment and librarianship, and finally, administration and management. Although most of the authors are affiliated with academic medical centres, an effort is made throughout to consider the hospital library context as well. In general, both published volumes are authoritative and welldocumented, providing an excellent introduction to the major issues and going into considerable depth. The first volume on reference and information services is also complemented by the latest edition of Roper and Boorkman's Introduction to Reference Sources in the

Health Sciences (3rd ed. MLA & Scarecrow Press, 1994.) of Roper and Boorkman's Introduction to Reference Sources in the Health Sciences (3rd ed. MLA & Scarecrow Press, 1994.) Owing to the very rapid developments in the profession, this series cannot be perfectly up-to-date. Important topics, such as the current developments in the use of the Internet, are regrettably absent. Nevertheless, the editors have included a great deal of useful information. Especially valuable are the discussions of evaluation techniques that appear throughout. Volume 1 on reference and information services covers the basics while going into some depth on database searching and other aspects of technology, to which two chapters are devoted. Another helpful chapter provides a thorough overview of management issues.

Volume 2 on educational services starts with a discussion of the context and ethics of library education and a theoretical overview of teaching and learning. An excellent discussion of standard educational methods follows, with a final chapter on evaluation and of teaching and learning. An excellent discussion of standard educational methods follows, with a final chapter on evaluation and future trends. Both published volumes are worthy successors to prior editions of the MLA Handbook. Despite the rapid developments in library and information science, MLA's new resource is a valuable guide to past and current practice as well as future trends. It will be especially valuable for the student and the new librarian or library manager seeking to get a foothold on changing terrain.

Posters offer an informal alternative to formal papers and represent an opportunity to share information about research, new projects or programmes and initiatives in the field. They are a visual representation which also allows presenter and conference attendees to meet and discuss common interests and problems.

As the term "Poster Session" suggests, information is mounted on a posterboard background and may be composed of any combination of texts, charts, graphs, photographs, objects and maps; occasionally a video or slide presentation is incorporated. Related handouts can also be a very popular adjunct to the session.

In this 20th anniversary year of CHLA/ABSC, the theme is CREATIVE CONNECTIONS so the topics for inclusion are limited only by your (or your library's) imagination and activities. Think of a circle of Clinical Care, Technology, Community and Education, with your library as the core that makes those connections possible! Finally, don't forget the historical links suggested by our anniversary as a further theme for exploration. Widening electronic resources and shrinking financial ones make creativity not only endless but necessary.

In addition to the formal poster session, the displays will remain up for an entire day for informal browsing. We will also be providing tables and poster panels. To contribute to this exciting session at this historic conference, call for more information or submit a proposal with a 350-400 word abstract. Deadline to be included in the Preliminary Program is December 31; for the Final Program the deadline is April 15, 1996.



# Library Focus

## Smart Health Research Library

When I introduce myself as a Technical Research Analyst for *Smart*Health, almost everyone reacts in the same way. They smile and say, "Aha, I see...., and what exactly does a Technical Research Analyst do?". Good question. As *Smart*Health is a rather new company, most of our employees' positions, including mine, are evolving. In many ways the only limitations to my job, are those that I set for myself.

SmartHealth is a wholly owned subsidiary of the Royal Bank. In 1992, changes to the Banking Act made it possible for banks to enter into the information technology

business. Health Care Technology is a rapidly emerging area within the health care industry. Medical Informatics, health informatics, telemedicine and teleradiology, all fall within the realm of Health Care Technology. Medicine and health care, like so much else these days, is becoming increasingly technology based. *Smart*Health, together with the Manitoba government, believe they have a way of preserving our health care system and saving millions of dollars in the process. Imagine a province wide health information network, where health care professionals would have access to vital medical information 24 hours a day, 7 days a week. During medical emergencies, when seconds count, doctors cannot afford to waste time waiting for your printed medical records to arrive. They need that vital information immediately. *Smart*Health and the provincial government want every health care professional to have that information at their finger tips. Allergies, chronic illnesses, immunization records, emergency contact information as well as drug and recent lab test histories would all be available on the network. These are just examples of the human side of the health information network. On the financial side, such a network could save millions of dollars. For example, it would be a way of curbing "double doctoring", Pharmacare fraud, and unnecessary duplication of laboratory tests.

Of primary concern to *Smart*Health and the Manitoba Government, is the security of your medical information. Several Stakeholder Committees, made up of Manitoba health care professionals, will decide what information to include, who will have access to the information, and how the information is used. One of these committees, the Confidentiality Committee, was established to pro-actively address the area of security and confidentiality of information stored and transferred on the network. As the Technical Research Analyst for *Smart*Health, I try to keep everyone in our company aware of changes occurring within the health care industry. Much of my time is spent on the Internet, clicking my way through the growing amount of information pertaining to the industry. As you are probably aware, there is a vast amount of information available. One of the most valuable sites I have come across is the home page of the Medical Records Institute (http://www.medrecinst.com/). To keep abreast of health care issues in Canada, I frequently visit the home page of Health Canada (http://hpb1.hwc.ca/links/englishe.html). The Canadian Medical Association home page, CMA Online (http://hpb1.hwc.ca/links/englishe.html) provides numerous links to other health related sites on the Web.

In Canada, health care is a provincial responsibility. As such, I am always interested in perusing the web sites of the various provincial health ministries. Most provincial government web sites are excellent sources of news releases. The Canadian Government Information on the Internet site

(http://library.uwaterloo.ca/discipline/Government/CanGuide/index.html) is a great source of links to provincial government sites. The Hansard, the verbatim publication of the Manitoba Legislative Assembly sessions, is available on the Web (http://www.gov.mb.ca/manitoba/leg-asmb/hansard/index.html) and is searchable. This

allows me to keep on top of the health care issues being discussed in Chambers rather easily.

To keep everyone at *Smart*Health updated on local issues, I maintain a daily newspaper clipping service. Any articles in the Winnipeg Free Press and Globe and Mail, pertaining to health care, medicine and computerized networks, are circulated. These articles are not retained, rather I use Globe Information Services to gain access to archive information from the above newspapers, on request. I also maintain a DIALOG account to satisfy virtually every other information need that may cross my desk, such as medical/health information, computers and networks, as well as business information.

Our journal collection is growing steadily. Titles include, Canadian Health Care Management, Healthcare Informatics, Healthcare Forum Journal, and Information Week, just to name a few. I also use the Uncover database to view the table of contents of many other journals, looking for articles that may be of interest to my colleagues. Since our journal collection is still rather small, I rely heavily on the document delivery services of CISTI and Canadian university libraries for many health and medical related articles. Fortunately, *Smart*Health is within the Royal Bank Group of Companies and therefore we are able to obtain most business related information and articles from the Information Services department of the Royal Bank head office in Toronto.

As a growing private sector company, we are naturally interested in what our competitors are up to. Increasingly, the WWW has become a valuable resource for corporate information. What used to be only available either in print form, or via commercial on-line databases, is now available free on the Internet. Corporate profiles, annual reports, and news releases are examples of what many companies are publishing on the Web. As the Technical Research Analyst, I am also the developer and keeper of the company and research library's databases. At the moment I am constructing a database for *Smart*Health's fixed assets as well as a database for the administration of the information services and the research library collection. In order to cut down on the amount of paper-based files I maintain, all ILL, document delivery and literature search requests are kept in the database. At the click of a button, I can produce reports and statistics detailing the status of an article or book on order, or how much has been spent on information services by a particular employee or department. Both of these databases are being developed using Microsoft Access 2.0 for Windows. When completed, these will be fully searchable and user friendly databases that can be accessed by any member of the company with no need for familiarity with Access at all.

So, there you have it, my explanation of what exactly a Technical Research Analyst for *Smart*Health does, at least for now. Undoubtedly, you will recognize that my job is similar to that of a Librarian, Information Specialist, Information Officer, etc. Personally, I am not too concerned about what my title is as long as I can continue to doing the type of work I enjoy. However, I do believe that the evolution of our titles could do our image a world of good. For example, how many people would assume that a Technical Research Analyst just checks-out books?
