

Though the celebration was quiet, modest and brief, "the spirit of co-operation and good-will", to which Rena alluded, appeared very much alive and well among those present.






Two retired members of the Manitoba Health Libraries Association, <u>ISOBEL STEEDMAN</u> and <u>BARBARA HENWOOD FAWCETT</u>, were named the Association's first honorary life members at the 10th anniversary meeting on May 6, 1987.

ISOBEL STEEDMAN became the first librarian of the Manitoba Cancer Treatment and Research Foundation when she was appointed, in 1962, to set up the Foundation's new library.

Isobel played a vital role in the creation of the Manitoba Health Libraries Association by taking the initiative in contacting the many small health libraries in the province and arranging several informal meetings of interested health library workers (acting as their secretary during these meetings) prior to the Association's founding in 1976, at which time she was instrumental in organizing the October meeting held at the Manitoba Association of Registered Nurses (when the Association was formally established).

Isobel was an active member of MHLA, serving both on the executive and on a variety of committees, both as a member and chairperson. From its inception, Isobel served on the Union Book Catalogue Committee, being one of the first to submit her library's holdings to that Committee. During both 1978/79 and 1980/81, she served on the Selected Books and Journals Committee as member of the Long Term Care Section of the Core List Committee. Isobel was on the MHO/MHLA Conference Planning Committee for two successive years and chaired the Programme Committee in 1982/83/. During 1983/84, she served on the executive as Treasurer of MHLA.



BARBARA HENWOOD FAWCETT was also a founding member of MHLA. She served on the executive as President in 1977/78 and was a member of the MHO/MHLA Conference Planning Committee for two successive years. At various times, she was member of the Publications Committee, and the Selected Books and Journals Core List Committee.

From its inception, in 1977, to 1981, Barbara chaired the Union List of Selected Serials Committee, during which time the first Union List of Selected Serials was produced.

She was also a Board member of the Canadian Health Libraries Association from 1978 to 1980, and acted as a Manitoba correspondent to <u>Bibliotheca</u> Medical Canadiana from 1979 to 1981.

The contributions made by ISOBEL STEEDMAN and BARBARA HENWOOD FAWCETT are substantial and enduring, and the Manitoba Health Libraries Association is proud to award its first two honorary life memberships to such outstanding original members.




The MHLA executive nominated our Association for the award and had asked Dallas Bagby, as one of the original members of the Task Force on Shared Services, to prepare a submission based on the Task Force on Shared Services project.

This report was submitted by the MHLA executive to Dorothy Fitzgerald, President of CHLA, prior to CHLA's annual meeting in Vancouver (i.e., before May 24th, 1987).

It is with great pleasure to report here that on Tuesday afternoon, May 26th, 1987, during the CHLA annual meeting (in Vancouver) it was announced that MHLA was the recipient of the CHLA/ABSC 10th Anniversary Commemorative Award.



Manitoba Health Libraries Association



The Manitoba Health Libraries Association has had an active and productive year. The membership approved a proposed revision to the constitution to include a clause on honorary life membership and all committee guidelines were examined. Those that had become outdated were revised, and new copies of the constitution, bylaws and guidelines were sent to the members.

Two standing committees were formally organized in 1986/87. The A/V Interest Group and Current Awareness which have been in existence for a number of years now have guidelines which list their membership, duties and responsibilities. For the first time, the A/V Interest Group organized a co-operative program for previewing commercially produced material which was successfully run among ten member institutions. A group of films was imported at one preview rate and each of the ten institutions participating in the project viewed the films for one week.

The Serials Holdings Committee which maintains and updates the membership's serials holdings distributed a new edition of the Union List of Selected Serials in February, 1987, and copies may be ordered from the treasurer.

The Manitoba Health Organizations has initiated a change in conference scheduling this year, moving to a once every eighteen months format, rather than the traditional annual conference each spring. The 1986/87 conference will now be held in October, 1987. The theme of the conference is The Faces of Change. The MHLA Conference Planning Committee has arranged for a half-day workshop entitled "Coping with Copyright: changing laws, changing technologies". Professor Dennis Marshall of the University of Manitoba Law Library has agreed to develop and conduct this workshop for us.

Our fall meeting, held at Rock Lake Health Centre, Crystal City, in October, was the first meeting in a rural setting since the fall of 1983. A large number of items were dealt with despite only twelve members being in attendance. The program was based on a videotape presentation "Cross Currents" which was followed by a discussion on public and interpersonal relations in a public service setting.

The winter meeting was hosted by the Medical Library, St. Boniface Hospital, with 20 members in attendance. Doctor Arthur Schafer, Professor of Philosophy, University of Manitoba, gave a thought provoking lecture on medical ethics. Following the program the members were given a guided tour of the beautiful new Carolyn Sifton Medical Library.

MHLA observed it tenth anniversary year in 1986/87. Its inaugural meeting was held in October, 1976, at the Manitoba Association of Registered Nurses. Many original members continue to hold membership and those no longer with the Association were invited to attend the anniversary meeting in May, which was also held at MARN. Two retired members were elected to honorary life membership: Isobel Steedman, who played a dominant role in the organization of the many small health libraries in Manitoba, and in the organization of MHLA; and Barbara Henwood Fawcett, a founding member, former president, and former CHLA member, who sat on many committees and was chairman of the Union List of Selected Serials from its inception in 1977 until 1981. A social hour was held after the meeting, at which time Rena Kroeker, our first president, gave an inspiring toast encouraging the members to continue the committment of co-operation and caring which has been the hallmark of the Association.

In 1986/87, a number of ad hoc committees were formed to deal with special concerns. Because of the perceived inadequacies of the Canadian Hospital Association's present list of activities for which statistics are kept by hospital libraries, the Committee on Management Information Systems was struck which prepared a statistics form to reflect the activities and work load in hospital libraries. The form will be reviewed after one year of use.

The Task Force on Infohealth was formed in response to the continuing interest in CHA's Infohealth project. It has been asked to prepare a report on the evaluation of the project and its value to health libraries.

Kathy Eagleton, MHLA member on the CHLA Task Force on Hospital Library Standards, is chair of the committee established at the annual meeting to work on recommendations in preparation for a fall meeting of the Task Force.


Membership in the Association rose to 71 in 1986/87, an increase of four members over 1985/86, consisting of 34 personal, 1 associate, and 36 institutional members.







During Kathy's tenure the first meeting outside Winnipeg was held in Brandon in September, 1979. Subsequent rural meetings were held in Selkirk and Portage la Prairie, and most recently at Crystal City. The Association's Bylaws state that "Every attempt shall be made to hold at least one meeting annually in a non-Winnipeg location". Given Manitoba's vast distances and concentration of the population in



Winnipeg this recommendation has been difficult to observe despite good intentions, and attempts to come to terms with it have not been too successful.

At the Association's recent winter meeting the Programme Committee gave notice of a motion to be presented to the membership which proposed that, if it is not possible to schedule fall meetings in a rural area, a travel stipend be paid by the Association to rural members who come to Winnipeg for the fall meeting.

This move will help defray the added expenses for rural members and, if successful in bringing more to meetings, will strengthen their voice in the Association's affairs.

The report of the Task Force on Shared Services had recommended the hiring of a permanent coordinator to oversee the projects generated from its reports and the Winnipeg Health Information Network Trial Project (WHINET) was established when an 18-month grant was obtained in 1983 to appoint a library coordinator. WHINET, although it is basically for hospitals in the Winnipeg area, also included the Manitoba Lung Association, several person-

al care homes, and the Shriners Hospital. Judy Inglis was chosen coorinator of the project with the responsibility to hold monthly workshops, give Medline demonstrations, distribute promotional posters, instructional brochures, and Current Awareness listings for allied health personnel. In addition, she was to analyze deficiencies in collections and interlibrary loan patterns of use. The analyses were to provide information necessary to proceed toward establishing cooperative collection development policies for the Winnipeg area. The project received a very enthusiastic response during the trial period and a task force was established by the Association to investigate ways and means of acquiring additional funding for the coordinator position after the grant expired. Although the project is now in abeyance, there is a reasonable possibility that a financial solution will be found and that the service will become active again in the near future.

In April, 1985 eight library associations held "Spring Together", a joint Manitoba library conference, which drew a large number of participants from both rural and urban areas. MHLA sponsored the programme "Evaluating consumer health materials", a topic of interest not only to our members but to librarians outside the health field as well. The speaker, Alan Rees, Professor of Library Science at Case Western University and co-compiler of "Consumer Health Information Sourcebook" gave a lively presentation which included audience involvement in examples of problems facing the public in its quest for information in health matters. The concept of a joint provincial library conference was new, and very successful as demonstrated from the enthusiastic response of the participants.

The Canadian Health Libraries Association which had been established in the fall of 1976 decided that it would approve in principle the granting of

Chapter status to local groups that meet the criteria of the Association..." and included the criteria in its constitution and bylaws. In 1977/78 the Manitoba Health Libraries Association was one of six regional groups to meet the requirements for chapter status. At that time, when its membership stood at 25 it already had a number of active committees, with several publications produced, including the first edition of the Union List of Serials for Manitoba Libraries, and Selected Books and Journals for Manitoba Health Care Facilities. As well, the Current Awareness service had been initiated, with regular circulation of the tables of contents of selected library journals.

Barbara Henwood, who had been MHLA president for 1977/78, was elected as the Association's first CHLA board member to a two-year term from 1978 to 1980. Another board member during that time was Patrick (PJ) Fawcett who had become Editor of the CHLA/ABSC Newsletter with issue number 8, which was to be the last under that name. In 1979 the title was changed to Bibliotheca Medica Canadiana, of which PJ edited the first two volumes in twelve issues. Other board members included Barbara Greeniaus, who became CHLA president in 1983/84, and Marilyn Hernandez, who served for two years from 1983 to 1985.

In 1983, MHLA hosted the Canadian Health Libraries Association's conference and annual meeting held in Winnipeg. Barbara Greeniaus, CHLA's incoming president was chairman of the planning committee; other members included Marilyn Hernandez as conference coordinator, with Barbara Greeniaus, Dallas Bagby and Audrey Kerr on the program committee. Sharon Allentuck was in charge of local arrangements, Doris Pritchard handled publicity, Gursharan Bawa acted as treasurer, and Barbara Carstens as secretary. As well, numerous member volunteers made valuable contributions to the success of the meeting. The conference theme "Rights and Responsibilities" was

stimulating for both speakers and delegates and the keynote speaker, Daniel LeTouze, an executive member of the Canadian Hospital Association, was an appropriate choice because of its recent library and information policy changes.

The social activities were outstanding: the welcome reception at the Winnipeg Art Gallery, place cards at the banquet to ensure that MHLA members would act as hosts to the visiting delegates, and the very entertaining Folklorama singers and dancers all added to the favorable impression of the conference.

The hard work and intense activity of the planning committee and other mem-

bers of the Association resulted in a conference that is still spoken of as one of CHLA's most outstanding and successful meetings.

MHLA has become known as one of the most active chapters in the Canadian Health Libraries Association. It is the individual members, dedicated to working together and contributing many hours of their time and effort, who have earned this high regard for the Association.

As the Manitoba Health Libraries Association enters its second decade, may it realize continued growth, steady progress in its endeavours, and ever greater achievements in the years ahead.





Readers are reminded that under the provisions of the Canadian Criminal Code any wilful damage to property constitutes a criminal offence for which severe penalties can be inflicted.

Minor damages render the offender liable to a fine of \$20.00, and he is also bound to compensate the owner up to a limit of \$20.00. Refusal to pay these sums is punished with imprisonment up to two months. (Sections 5.39-540).

More serious damage can be visited with a term of imprisonment up to two years. (Section 510-E).

CHLA TASK FORCE ON HOSPITAL LIBRARY STANDARDS

REPORT

KATHY EAGLETON Library Services Brandon General Hospital

The first meeting of the Task Force was held in Toronto on April 30th and May 1st,1987. Terms of reference were drawn up and a plan of action was formulated. We also tested our hand at some actual revisions.

A package of information will be forwarded after the Annual Meeting to all incoming Chapter Presidents. In the meantime, please be thinking about the present standards and what changes should be made.

IF DESIRABLE, A SPECIAL COMMITTEE COULD BE BE STRUCK BY MHLA TO PROVIDE INPUT. SINCE I AM RESPONSIBLE FOR COORDINATING WESTERN CANADA INPUT, I WOULD APPRECIATE ALL THE HELP AVAILABLE.

We have made the following decisions already:

- 1. The format to be used will be based on that in the 1986 CCHA <u>Guide to Accreditation</u>, pages 147-150.
- 2. Other standards to be used in the process are:
- Manual for assessing the quality of health sciences libraries in hospitals, Albany, New York, 1983.
- Minimum standards for health sciences libraries in hospitals, Medical Library Association, 1984.
- "Canadian standards for hospital libraries". Canadian Medical Association

 Journal, May 17, 1975, pages 1271-1274

 (the original Canadian standards).

All these titles will be included in _ the 'Presidents' package' to come later.



This Task Force was established and approved by CHLA at its November, 1986 meeting. - Editor's note

- 3. Contact has been made with CCHA and we will actively seek for the standards, as re-written, to be adopted by CCHA for publication in their Guide.
- 4. We will meet again in the Fall (probably early October). By that date, we will each have drafted revised Standards I through IV as found in the 1986 CCHA Guide (pages 147-149).
- 5. We will add a Standard, to become Standard VI, called Resources and Services (or something akin). Standards VI and VII will become Standards VII and VIII.
- 6. For smaller hospitals, the CCHA's An interpretation with special reference to the needs of small acute health care facilities will be considered.
- 7. In addition, a DESCRIPTIVE section will be written to parallel the questionnaire format of the 1986

 <u>Guide</u>, and QUANTITATIVE measures will be drafted, probably using categories of hospitals criteria.

 (See the "Albany" manual for ideas).
- 8. We anticipate the work to be completed by May, 1989.


Please feel free to contact me individually or collectively with proposals or discussion [before the next Task Force meeting this coming October].

"Health professionals have traditionally shown a reluctance to share health information. This is contrary to the norm for librarians, whose whole aim in life is to make information available; it requires some consideration for the librarian in the hospital setting".

"Information is power, especially when it is not shared...Power can be further maintained by making the information as mysterious and inaccessible as possible so that only the health professional can understand what it means. This is the problem which all hospital librarians face".

"The hospital library...should alert itself to the responsibilities of providing both disease-oriented and prevention-oriented materials, presented at a level comprehensible to the lay public".

"The library staff can provide traditional expertise in collection and dissemination and act as a back-up resource; They can also, should they choose, become initiators, consensus makers and facilitators of this vital area of health information for the consumer".

"Ask yourself these questions. When I am a patient, what information will I want and how will I get it? When you can answer these questions to your satisfaction you will be well on the way to becoming the information provider which all hospitals need".

"Until recently...there existed in libraries a taboo surrounding the distribution of [patient] information to the public...The general consensus now among librarians and lawyers is that there are no legal reasons for not providing health information to individuals who want it".

"The purpose of health information is to supplement and reinforce information already supplied by a health care professional.Legally, it is unnecessary to fear that the library will be charged with practising medicine without a licence as long as information is merely relayed and not interpreted; interpretation might be misconstrued as an attempted diagnosis. Rather than endangering the library, librarians are helping protect the patients and doctors. Given the knowledge which medical librarians specialize in, they can be of great service by helping provide the layperson with accurate health information".

"The formation of library networks has proven to be a valuable method of distributing quality health information to the consumer. As a result of the current interest in this area, a team of medical librarians and public librarians was formed to explore the possibility of twinning services".

"A cooperative effort between medical and public libraries would fill an obvious need. With such a network working in conjunction with health agencies and health care professionals, the consumer would be certain of receiving quality health information".

The concept of the patient's right 'to participate in decision-making affecting his health with the health professional involved in his care'...has been reinforced by the Supreme Court of Canada...In the eyes of the law, the distribution of health information enables the patients to reach their decision".

"As [Ellen] Gartenfeld, co-ordinator of the Community Health Information Network (CHIN), pointed out [in 1982]: "We're not providing 'do-it-yourself' medicine; we're supporting people in their interaction with their health professionals".



The development of pathfinders is a joint project of USDA's Food and Nutrition Information Center and the Pennsylvania State University's Nutrition Information & Resource Center.






erom the Editor's Desk...
